

Instructions for ADELPHI authors

- Adelphis should be submitted as a Word document by email. Authors should include their full affiliation, appointments, address, telephone and fax numbers and email address. Where there is more than one author, the author to whom proofs should be sent should be indicated.

- All documents should be submitted in PC-compatible Word format (not as '.wps' files, which cannot be opened in Word). There is no need to save documents in Rich Text Format. Line spacing should be 1.5 between sentences.
- Adelphis are normally limited to 40,000 words. You should not submit a longer manuscript unless this has already been agreed with the Editor.
- The text should be preceded by a context-setting introduction and concluded with a policy-relevant, forward-looking summary.
- All manuscripts need to be appropriately edited. While the editing process will be conducted in consultation with the author, the IISS reserves the right to decide on the proper content of each Adelphi.
- A Table of Contents and Glossary of abbreviations should be provided.
- British spelling is used as standard.
Exception 1: official titles or names, when the US spelling is used, e.g., the US Department of Defense, the Japanese Defense Agency.
Exception 2: direct quotations from text sources. The original punctuation and spelling is retained.
- Dates should follow the format 20 December 2004 not December 20, 2004. The 1990s, not the nineties.
- All quantities must be given in metric values. The following website is useful: <http://www.concrete.com/calculatorsconversion.htm#length>.
- Subheadings should be used wherever possible.
- All acronyms must be spelled out at first mention (except for very common ones: EU, the UN, NATO, the US, GDP).
- Please also note that there are no full stops in acronyms or titles: US, Dr, EU.
- Full names and titles required at first mention: the British Prime Minister Tony Blair, subsequently Blair.
- Maps and tables should be of sufficiently high quality to enable reproduction by the publications department and will be submitted as proofs for inspection.
- Authors are responsible for obtaining copyright permission as necessary.
- Proofs will be sent to the author for correction of errors.
- The IISS will provide a suitable cover design, in consultation with the author. However, the Editor reserves the right to decide on the final design.
- The author will receive 20 copies of the Adelphi.
- Authors are assumed to transfer to the IISS copyright of their words.
- Adelphi books are endnoted. Notes in the text should be cited consecutively by numbers and listed at the end of the article in numerical order according to the styles shown below. We do not use the Harvard system (Bloggs, 2004). **Any material received in this form will be sent back to the author to be redone in the house style (given below).**
- Citations should be given in full at first mention. For subsequent mentions, only the author's surname and the article/book title (in full) are required.

I. Books

Book citations should follow the basic format:

Author, *Title* (place of publication: publisher, year of publication), page reference(s)

If the publisher is American, the name of the town or city in which the company is based should be followed by the postal abbreviation: Boston, MA; New Haven, CT. The only exception is New York. Note IISS house style is Washington DC, **not** Washington, D.C.

X. Internet Sources / Citation of URLs

It is the author's responsibility to ensure that the URLs cited are correct. URLs can either be given in full (including htm/PDF suffix, otherwise the link will not work) OR a 'base' website from which a reader can reasonably be expected to locate the required document, e.g., <http://www.dod.gov/speeches/secdef.html>

For long URLs, please 'copy and paste' the site name from your browser menu bar rather than trying to copy it manually – this saves editorial time in tracking down the correct URL later.

Links to search results usually don't work and are not valid as URL references.

If online information has been accessed via a subscription-only service, you need to name this service as part of the reference, e.g. Lexis-Nexis.

There is no need to give the date of access. It is inevitable that some URLs will 'expire' in the future (just as books go out of print), but all will have been functioning and valid at the time of editing.

The assistant editor will check all URLs. If she cannot access them, the author will have to find an alternative reference.
